Summary

This informal Working Group included 19 legislators, 10 of whom attended at least one meeting; about 6 were regulars.

We held 4 meetings at 3-week intervals July through September. We received comments from one or more representatives of 24 stakeholder organizations. (List at the end.)

THERMAL EFFICIENCY POLICY PRIORITIES

- 1. Implement robust enforcement of Residential Building Energy Standards, RBES ("energy code").
- 2. Support passage of S.163 to require mandatory builder registration with voluntary certifications.
- 3. Facilitate and incentivize education and training opportunities for builders, tradespeople, home inspectors, appraisers, realtors, mortgage lenders, and students at high school and adult level.
- 4. Increase sustained funding for Weatherization Assistance Program, and establish sustainable funding and financing for moderate-income weatherization.
- 5. Expand the State's School Energy Management Program, currently available to public school facilities, to Vermont State College facilities.
- 6. Extend the collaboration between Efficiency Vermont and the State's Building and General Services to be available to municipal facilities.
- 7. Ensure Public Service Dept establishes panel to continue RBES/CBES update cycle to meet 2016 Comprehensive Energy Plan goal of net-zero-ready new construction standards by 2030.

Proposal Details

- 1. Implement robust enforcement mechanisms of RBES.
 - 1.1. **Establish a State 'authority having jurisdiction' (AHJ)** to interpret and enforce RBES.
 - 1.1.1. The AHJ is best located at the Division of Fire Safety (DFS, in Department of Public Safety), in coordination with the state energy office, the Public Service Department (PSD).¹
 - 1.1.2. Empower AHJ to house central database to track projects and compliance.
 - 1.1.3. Authorize staffing to carry out AHJ functions, at inception one FTE and part-time clerical assistance, to be funded initially by appropriation and on a continuing basis primarily by RBES filing fees.

¹ DFS currently has jurisdiction over all "public buildings," which includes *all except* single-family detached owner-occupied houses. They administer all life-safety codes. They are best situated to resolve conflicts between code requirements.

1.2. Compliance Enforcement

- 1.2.1. **All except new construction**: No change to RBES § R401.3.² (Certification of compliance is currently required.)
- 1.2.2. **New construction:** Require documentation at loan closing of proper filing of RBES certificate to avoid title defect.
- 1.2.3. Act 250 condition (Act 250 projects only). Require energy modeling and design plan to meet RBES prior to obtaining Act 250 permit.
- 1.3. Incentivize energy audits for existing buildings not served by current programs.³
- 2. **Endorse mandatory contractor registration** at Office of Professional Regulation, with voluntary state-sanctioned certifications.⁴
- **3.** Facilitate education and training opportunities for builders, tradespeople, home inspectors, appraisers, realtors, mortgage lenders, and high school and adult students.
 - 3.1. As part of builder registration, direct OPR to identify and approve one of more **certifications for "home performance"** or building science knowledge.
 - 3.2. Direct DFS to identify and approve a **building science component for existing trade licensing** competency requirements.
 - 3.3. Require **sales industry** players (realtors, home inspectors, appraisers, and/or lenders) to provide nontechnical, **consumer-oriented RBES brochure** to buyers and refinancing owners, developed in coordination with PSD.
 - 3.4. **Establish incentives for training,** certification, and continuing education for builder, trade and sales industry.⁵

- 3.5. Direct PSD to coordinate with Efficiency Vermont/VEIC to explore piloting **Green Mortgage program** with Fannie Mae and Freddie Mac.
- 3.6. Require **disclosure of historic utility costs** on real estate sale listings.

- 3.7. Continue work on **Energy Labeling**.⁶
- 3.8. **General education.** Provide **training to instructors** in application of building science to high-school STEM, high-school and adult Career & Tech Ed, and K-12 science/physics.
- 4. **Increase sustained funding** for residential energy efficiency for
 - low-income Weatherization Assistance Program (up to 80% area median income)
 - moderate-income households (~ 80-120% area median income)
- 5. **Expand SEMP** (School Energy Management Program), currently covering public school facilities, **to include Vermont State College system.**
- 6. **Extend the collaboration** between Efficiency Vermont and the State's Building and General Services to be available **to municipal facilities**.
- 7. Ensure Public Service Dept establishes panel to **continue RBES/CBES update** cycle to meet 2016 Comprehensive Energy Plan goal of net-zero-ready new-construction standards by 2030.
